Terms and Conditions of the KDMA 2012 Tour

Air Travel

Flight schedules are subject to change without notice. Changes will be allowed to the return sectors, subject to availability, with an amendment fee of AUD \$75.00 per person plus any difference in airfare or taxes. Date changes after ticketing will incur a reissue fee in addition to the amendment fee. Rerouting is not permitted after ticketing. Name changes after ticketing incur full cancellation fees plus administration fees. Delegates making independent bookings on flights must advise ABC Travel of your arrangements.

Passport & Visa Requirements

ABC Travel will require a copy of your passport before any airline tickets will be issued. Passports must have 6 months validity from the date of your return to Australia. If you do not meet this minimum requirement, you will need to apply for a new passport. If you do not hold an Australian passport, you need to ensure your re-entry visa will be current for your return into Australia. Australian passport holders will require a Visa for entry to Kenya. ABC Travel can assist with the processing of these visas (price not included in the Conference Costs).

Published Costs

All costs listed in the Conference brochure and additional costs listed in your post arrangements, are correct at the time of publication (1st September 2011). They are all subject to change due to currency fluctuations, tour operator & airline increases, fuel surcharges & changes to government taxes, without notice to the passenger. Tours are based on minimum numbers and if that number is not reached, tours may be cancelled, altered or increased. All increased costs will have to be paid by the passenger prior to documents being issued. Normal cancellation fees will apply if the passenger wishes to cancel the reservation instead of paying the increased costs.
